OUR LAST MEETING

Waslon March 21 at Petite Auberge in Toco Hills. About 50-75 members and guests were there. Invocation was by Lucille Isbell . The guests at the head table were: Marie & Rik Eriksson, Stan Adams, Billie Lee (Shirley's replacement in I&E) and Phil Archibald. Stan gave a very interesting talk on how things were in the F. S.. He told mostly of the curtailment of a lot of programs, particularly budget cuts involving S&PF with state projects-the basis of the cuts being that "the states should handle their own programs without federal assistance." He also dwelled on how the NF lands should be managed and criticized the herbicides on NF lands, which seemed to be the #1 issue. He indicated that herbicides were banned on NF lands which are in use every day in every household. Announced that Harry Rossoll had been awarded the SILVER SMOKEY BEAR TROPHY - the 40th anniversary of Smokey Bear and mentioned it as the highest award made to an individual. (Congratulations harry). Phil - Program Chairman, thanked Stan and introduced Rik Eriksson who gave a most informative -1talk on the organization known as NARFE-(National Association of Metired Federal Employees).

(Last Meeting continued):Rik divided his talk into three parts: (1) NARFE (2) Narfe Pact and (3) legislation in Ga. Pointed out that Ga. Legislature - through Narfe - obtained a \$2000 deduction in State income tax for Narfe members. Indicated that Narfe needed new members, pointing out that in their dealings with Congress, a million membership would amount to a "clout" with Congress and State Legislature. He discussed Civil Service -vs- Social Security and urged all retirees to join up with Narfe and provided membership blanks As stated - Rik gave an informative talk and is quite capable of doing so, since he was President of the local chapter in this area. He talked of other subjects but was unable to get them all down. Guests included Lucille's grandson; Lionel Johnson introduced a sister in law; Jim Cheek was introduced but he stated he was a member and just returned "back home" from Miss. Huber had a neighbor guest; Polly Brandt as an out of town member. Sam Johnson reported "we are healthy with a balance of \$1500 to use. A member of the Wives' Club invited members to attend a wine-cheese party. Mayfield brought up attending a N. C. retirees meeting (See Lew Mielke's letter as to details) but no one seemed interesting. Andy Brands, George Schaeffer and Art Collins were recognized as 50-year members of SAF. WHAT OUR RETIREES ARE DOING



E. B. "RIP" WILLIAMS:






