Next to Singapore-beautiful city wiht no litter. In a wealthy section, I counted one Mercedes to every seven other makes. High light was a Trishaw (cicycle ridden by a native containing a rickshaw on the side for a passenger) ride to the famous "affles Hotel for a Sinapore Sling. Flying into Hong Kong at night was the most beautiful sight I ever saw - the many tall modern buildings all lighted and extended up the mountain sides for miles. Hong Kong is a shoppers paradise. It specializes for tailored made dresses and suits. The train trip into Canton, China was great. Our coach with velvet draperies; lace curtains and slip covered seats. My best impression of China was the billion people. 'hey ride millions of bicycles and have the right of way on roads. People were friendly, wave, smile and, in on of the stops they surround you, just to look and smile. Adults are dressed in Mao costume, navy top and pants. Children gaily dressed. People live on walks outside their compounds, cooking, washing etc. Live in small rooms, mostly poorly constructed. In the country, people live in Communes, like a small village near the fields. They have no farm machinery. They stand bent over in the fields in water, weeding and transplanting rice. Water Buffalo are used to play. They do have irrigation. We visited primitive hospitals and they were dirty and badly equipped. Hospitals in modern cities are real good. Hotels and the best were not too good, but we always had twin beds and private bathrooms. Each room had drinkable water in a carafe, with hot water in thermos and loose tea. They're modernizing their hotels, but workmanship is poor. Had plenty to eat-sat at a table for 12-used chop sticks. The Peking Duck was delicious. Fish, shrimp and pork were good but the webbing from duck feet etc. were not eatable.

In Peking we enjoyed the Forbidden City, Summer Palace, Ming Tombs and a trip to the Great Wall-view from the Wall was impressive as was the Wall itself. (Marian-no more room) (will continue it in the next issue of DR)

CONSOLIDATING NATIONAL FORESTS AND CLOSING A FOREST SUPERVISORS OFFICE

Soon after the Eisenhower was elected President, word reached the Regional Office in Atlanta, that the administration expected the consolidation of, at least, two National Forests and the closing of one Forest Supervisor's office in Region 8. There had been previous discussion of combining the two North Carolina National Forests. So, it was no surprise, when we learned the Forest Supervisors Office in Franklin was to be closed and the Mantahala and Pisgah National Forests combined with headquarters at Asheville. The Supervisor offices were not large, by todays

The word reached Atlanta in mid-week, so I told my folks to phone Supervisor Renshaw, in Franklin, to come to Atlanta promptly. In Atlanta, kenshaw was notified of the planned action and he was offered a transfer to the kegional Office. The Asheville office was alerted to prepare to accomodate the addition of the Mantahala Office. It was planned to continue the kanger office in Franklin. Except for the Supervisor, no positions were to be dropped in the move to Asheville. Preparations were made to move the office with government trucks on the coming weekend. Haste in making the move was used in order to complete the job before the weekly newspaper could generate a campaign of protest. Actually, some protests developed, but they were not organized and the Administration fully supported the action.

The main significance of this incident illustrated that once a decision is made by the bureaucracy, assuming it is correct in the first place, the action can be carried out with dispatch and without encumbering reviews and justifications, none of which could change the decision in thelong run.

A PROBLEM ENCOUNTERED IN GETTING ARMY TROOPS TO ASSIST IN FIRE CONTROL (Ed: AM SURE THIS ARTICLE REFERS TO THE 1952 FIRES ON CHEROKEE)

As so often happens, one very dry autum, fires were wide spread in Tennessee. So many fires were out of control that the State committed all possible fire fighting forces and the National Guard was activated to provide supplemental assistance. Late in the season, fires on the national forest began to intensify. All available In-service manpower was soon committed and no help could be expected from the State. Once all civilian man power was committed, requests were made to the military for troops for fire fighting. The military was cooperative, but would not provide troops for fire fighting. The reason given that troops could not be provided, was that no federal troops were stationed in Tennessee. In order to move troops across State lines, a request would have to come from the Governor. In this case, the governor was agreeable, but stated that if federal troops were requested, martial law would have to be declared and such a step would upset normal local government operation. He did not want to take this step. The result was that the request of the Forest Service was stymied and no troops were ordered to assist in fire control.

A. W. Hartman, in charge of fire control for the Region was in Tennessee, assisting the Forest Supervisor. I was handling the fire control work in the ^hegional Office. In regard to the request for troops, I was dealing with the Corps Area headquarters in Atlanta. As it so often seems to happen, this matter came to a head on the week end. I stayed in constant touch with the Corps Area Headquaters, and was finally told that troops would not be forthcoming, in spite of our obvious need. So late Sunday evening, I imformed the Corps Area Headquarters that government property was being destroyed by fire and lives were in danger and a request was being rejected. I informed the military that I would notify the "ecretary of Agriculture of the facts. I did then call the ^F orest "ervice in "ashington with this information.

Larly the following morning, I got a call at the office from the Corps Area Headquarters, asking me to meet the General and fly to Tennessee. I joined the General and his staff and we flew to the fires where we were met by Forest Service personnel and transported to a fire camp. There we were briefed and had lunch. While eating, a heavy rain started, but the General decided that troops were needed and he ordered a group from Fort Bragg to fly in to our aid at once and a second larger group to come by ground transport and remain as long as needed. The General offered the finest in cooperation and, as soon as he saw the situation, he ordered troops without worrying about crossing state lines. The interesting aspect of this situation was the problem originally encountered in moving troops across state lines and the effective action taken by the General as soon as he visualized the situation. The action of the General was most effective when he elected to take it. Military cooperation remained excellent
