Region 8's new Regional Forester is ELIZABETH (LIZ) AGPAOA who had been serving as Acting Regional Forester for the Pacific Northwest Region until appointed by Chief Gail Kimbell. Liz will oversee the 14 national forests in 13 southern states and Puerto Rico. She succeeds Chuck Myers who recently became Associate Deputy Chief for the National Forest System in Washington, D.C.

"Liz brings a wealth of experience in forest management and cooperating with state and private forestry programs," said Chief Kimbell. "She has a deep belief in public service and conservation management that will serve her well in this new assignment." Liz began her Forest Service career in 1979 as district biologist on the Willamette National Forest. She has since served as a line officer at the district, forest and regional levels, and has served as Chief of Staff in Washington, D.C. Her forest management experience includes line officer assignments in Oregon, New Mexico, Oklahoma and Texas. She holds a B.S. degree in wildlife management and an M.S. degree in natural resource management from Humbolt State University in Arcata, California. Her husband, Dan Crittenden, also has a career with the Forest Service.

President's Corner

Hope everyone has had a healthy 2008. A Merry Christmas and a Happy New Year to all our 369 members. The best to all in 2009 for a healthy and prosperous year.

2008 may not have been the most prosperous (especially October 2008) year of our lives. But thanks to most of our government pensions, I would hope that most of us survived this wild year for the economy. The good news, as most of you have probably heard, is that effective December 1, and to be reflected in the January 2009 annuity payments is a 5.8 % COLA for Civil Service retirees and 4.8 % for FERS retirees over the age of 62. FERS retirees will receive a 5.8 % adjustment to their Social Security benefit.

The can-do Forest Service, Region 8 and other Forest Service Regions, came through once more during a time of disaster when they committed resources to the rescue and relief efforts in the recent hurricanes that hit the Southern US. Region 8 is currently doing restoration work on the National Forests that were damaged by the storm.

On the bad news side, this year has been a very tragic year for wildland firefighters. The information we have shows 25 fire-related deaths on local, state, and federal wildland fires, including 9 in a helicopter crash on the Shasta-Trinity National Forests.

The Forest Service budget, as well as other federal agencies, is being constrained due to the current economic conditions and the demands on the federal budget. The Forest Service is currently working on continued funding at the 2008 level for the first half of 2009 and it's impossible to predict whether an appropriation will be passed for the second half of 2009. The tightly constrained budget situation makes it imperative that the costs of fire suppression be separated from the regular Forest Service budget.

Most of you have probably heard that we have a new Regional Forester in the Southern Region. She is Liz Agpaoa and comes to us from Region 6. We plan on having her speak to us at our June 2009 luncheon. She had a conflict with the National Leadership meeting in December. She did call me to introduce herself and tell me she was extremely interested in working and collaborating with the Southern Region retirees. She asked what opportunities were available for her to meet with retirees across the Region. I told her of the ones listed in the Dixie Ranger. Consider contacting your local Forest Supervisor so you can all meet her when she's on the Forest. I know she was very active with the retirees in R-6. She will be attending the "John McGuire Award" presentation in South Carolina on Nov. 14th. See related article for details, page 12.

FRANCIS MARION-SUMPTER NATIONAL FORESTS RETIREES FIELD TRIP by Glinda Wood

The regular FM&Sumter retiree semi-annual meeting was a hosted field trip, which former Forest Supervisor Don Eng had arranged with SO staff. The trip took place on October 15, which was a lovely fall day. Retirees in attendance were: Ron Boozer, Tommy and Janet Kinard (Enoree District); Bill Gause (Wambaw District); Dave and Liz Adams, Paul Meyers, Colette Phillips, Dave Rosdahl and Jim and Glenda Wood (S/O). We renewed friendships with familiar personnel in the S/O and enjoyed the coffee they had waiting for us when we arrived. We then left via caravan at approximately 7:30 a.m. and traveled to the Long Cane District, our scheduled destination.

Upon arrival at the Forks Area Trail System Trailhead on the District, we were treated to home-made coffee cake, hot coffee and cold drinks; and given a briefing on the FATS mountain biking trail. This 38-mile trail was recently completed, in conjunction with SORBA (Southern Off-Road Bicycle Association and SCPRT(South Carolina Parks, Recreation and Tourism).

Additional topics/sites included: update on the goals and developed/dispersed/backcountry recreation for the Chattooga Wild and Scenic River; threats from insects or disease, such as the southern pine beetle and hemlock wooly adelgid; key bridge restoration project; equestrian use on the Sumter NF; land ownership adjustment; timber program and biomass; RENEW Project (including use of prescribed fire); stewardship agreement with NWTF (National Wild Turkey Federation); partnership activities with NWTF (Wheelin' Sportsmen, fishing rodeos, women in the outdoors);current Sumter LRMP goals for each of the areas in which we were briefed; and an overview in the NWTF conference room related to the coordinated efforts of the FS/NWTF. A tour of the NWTF followed, with interesting commentary by their Interpretive Programs Coordinator. Presenters included the Forest Supervisor Jerome Thomas, Anne Kiser, Edgefield District Ranger; Glen Kansanback, District Natural Resource Specialist; Jay Purnell, S/O Silviculturist; Peggy Nadler, S/O Lands Program Manager; John Dent, S/O Timber Sales Forester; Donny

Ray, District Biological Technician; Steve Wilhelm, District Forester; Gary Peters, S/O Wildlife Program Manager; and NWTF representatives.

Our noon-time lunch was a delicious boxed lunch, which we enjoyed at the Lick Fork Lake Recreation Area. It was a full and very interesting one-day trip for retiree participants....agenda for the field trip was well planed and executed, selection of the various sites we visited was excellent and presenters were articulate. Presentations peaked the interest of retirees, as well as their spouses (who had no Forest Service related background/experience). It was clearly evident the Francis Marion and Sumter is blessed with visionaries and excellent leadership. At the end of the day, attendees appeared to have a confident sense of predication that the Forest Service will continue to be a progressive and exemplary organization.

STEVE McCORQUODALE - Louisiana - We really appreciate each issue, especially the addition of the color photos, and Dave Jolly's call to support the National Museum in the last issue.



This summer we spent nearly six weeks visiting and camping in several national forests in the northwest. In route, we had the opportunity to visit the site of the National Museum of Forest Service History located adjacent to the Missoula Smoke Jumper Base and the Missoula Fire Science Laboratory. John Drake, who is a member of the museum Board of Directors and was in R-8 in Mississippi during the 70's, gave us a tour of the site which already includes outside exhibits; the old Bungalow Ranger District Ranger's residence from the Clearwater National Forest that had been moved onto the site as well as a replica of a nearby fire tower. We also got to see the architect's drawings of the museum.

To be honest, last year we probably would not have included this stop in our trip. However, last winter a friend who was a curator for a local museum dropped off a large box of old Forest Service publications dating back to 1908 through the CCC period. I spent about a week browsing through these old documents and was just plain overwhelmed. All of these early employees' detailed research and their dedication that shaped our nation's forests was right there in front of me. We had read about the plans for the National Museum in *The Dixie Ranger* and I knew right then that the documents belonged there and that I wanted to be a part of it. The cost for annual membership is actually quite a bargain, less than half a tank full at the gas pump.

Some of these early publications were about nursery practices, protecting the forests from fire, grazing practices, identification and grading of trees, instructions for CCC instructors, and congressional hearings on plans for American forestry, and early land purchases such as the YLT. It reinforced to me how

important it is to have such organizations as the National Museum, Cradle of Forestry, Civilian Conservation Corp Legacy, Forest History Center in North Carolina, as well the Southern (and other) Forest Service Retirees Associations to preserve the history of the Forest Service for our retirees, public, and especially our current employees. It also made me appreciate (even more) the fine job that Jim McConnell does as historian. We are very pleased to see things are progressing at the museum like the timber posts for the structure coming in from across the country. We look forward to returning again soon.

In every cutback in agency budgets in the past, Research, State and Private, and International Forestry programs have always been prime targets. We need to be advocates for these programs that are vital to successful protection and management of our Nation's forests.

Presented to the Enoree Ranger District, Sumter National Forest


